Press Release Q2 FY20

Jash Engineering Ltd. announces Q2 FY20 results with consolidated Revenue of ₹567.3 million and EBITDA of ₹83.5 million.

Receives orders from Singapore and Qatar worth approximately US\$ 10.7 mn (Rs. 76 Cr.)

6th November 2019, Indore, India – Jash Engineering Ltd. (NSE: JASH) leading manufacturer of water treatment and flow control equipment, reported its results for the fiscal second quarter and half year ended September 30, 2019.

Highlights for the quarter ended 30th September, 2019:

- Operating revenue for the quarter at ₹567.3 million, up by 5.2% YoY from ₹539.1 million in FY19 Q2.
- EBITDA for the guarter at ₹83.5 million, up by 115% YoY from ₹38.7 million in FY19 Q2.
- EBITDA margin for the quarter at 14.7% up by 753bps YoY from 7.18% in FY19 Q2.
- Profit after Tax (PAT) for the quarter at ₹26.7 million, up by 1,235% YoY from ₹2.0 million in FY19 Q2.
- EPS for the quarter is 2.26 as compared to ₹0.17 in FY19 Q2.
- Total order book stood at ₹3,154.8 million as of October.

Highlights for half year ended 30th September, 2019:

- Revenue stood at ₹1,137.2 million, up by 5.6% YoY from 1,077 million in FY19 H1.
- EBITDA stood at ₹128 million, up by 73.6% YoY from ₹73.6 million in FY19 H1.
- EBITDA margin for H1 at 11.3% up by 441bps YoY from 6.8% in FY19 H1.
- Profit after Tax stood at ₹26.2 million, up by 385% YoY from ₹5.4 million in FY19 H1.
- EPS for H1 is ₹2.22 as compared to ₹0.46 in FY19 H1.

Mr. Pratik Patel, Managing Director said, "I am pleased with our second quarter performance with sales grew by 5.2% and EBITDA margins to 115% driven by strong order book and focus on disciplined execution. We are delighted to inform that in the month of October 2019 we have moved to NSE main board from Emerge platform of NSE."

In addition to worth approximately USD 8.2 million (Rs. 58 cr.) order from Singapore that we received before Diwali, we have now received our single biggest order till now from Middle East. This order is for gates worth approximately USD 2.5 million (Rs. 18 cr.) from Qatar. So we are slowly moving in line with export centric strategy that we decided few years' back."

He further added "We continue to see many paths of growth as we execute our strategy of being a leading water treatment and flow control equipment manufacturer."
