1. In the month of July 2019, the consolidated orders received by the Company are worth Rs. 23.02 crores out of which Rs. 9.41 crores worth of orders are for Indian market and Rs. 13.61 crores worth of orders are for markets outside India.

The significant contributors to the monthly order booking of July 2019 are Triveni Engineering & Industries Ltd. – Noida, Rajkamal Builders – Ahmedabad, H N Construction Pvt. Ltd. – Bokaro and VA Tech Wabag- Chennai from India and Sanli M&E Engg Pte. Ltd.- Singapore, Al Raida Engg. Industrial Services- Qatar from abroad.

2. As on 1<sup>st</sup> August 2019, the total outstanding consolidated order book position of the Company is Rs. 245.56 crores out of which Rs. 137.74 crores worth of orders are for Indian market and Rs. 107.82 crores worth of orders are for markets outside India.

Of the total outstanding consolidated order of Rs. 107.82 crores for markets out of India, Rs. 65.61 crores constitute orders for USA market and Rs. 42.21 crores constitute orders for rest of the world.

3. As on 1<sup>st</sup> August 2019, further consolidated orders worth Rs. 21.56 crores are already negotiated and of this Rs. 13.58 crores worth of orders are from Indian market and Rs. 7.98 crores worth of orders are for markets outside India.
