This is to inform you as under:

1. In the month of February 2020, the consolidated orders received by the Company are worth Rs. 16.27 crores out of which Rs. 11.84 crores worth of orders are for Indian market and Rs. 4.43 crores worth of orders are for markets outside India.

The significant contributors to the monthly order booking of February 2020 are Larsen & Toubro – Chennai, Badgurjar & Co. – Nashik & Subhash Infraengineers – Gurugram from India and Atal Engineering – Hongkong & Waterfront Fluid Control – U.K. from abroad.

2. As on 1st March 2020, the total outstanding consolidated order book position of the Company is Rs. 339.35 crores out of which Rs. 147.40 crores worth of orders are for Indian market and Rs. 191.95 crores worth of orders are for markets outside India.

Of the total outstanding consolidated order of Rs. 191.95 crores for markets out of India, Rs. 82.25 crores constitute orders for USA market and Rs. 109.7 crores constitute orders for rest of the world.

3. As on 1st March 2020, further consolidated orders worth Rs. 30.66 crores are already negotiated and of this Rs. 17.63 crores worth of orders are from Indian market and Rs. 13.03 crores worth of orders are for markets outside India.
