This is to inform you as under:

1. In the month of May 2018, the consolidated orders received by the Company are worth Rs. 39.13 crores out of which Rs. 18.27 crores worth of orders are for Indian market and Rs. 20.86 crores worth of orders are for markets outside India.

The significant contributors to the monthly order booking of May 2018 are Doosan Power, Suez India, UEM India, BGR Energy, Eco Protection from India and HSL Constructor — Singapore, Petrofac — UAE and Atal Engineering — Hongkong from abroad.

 As on 1st June 2018, the total outstanding consolidated order book position of the Company is Rs. 217.53 crores out of which Rs. 116.74 crores worth of orders are for Indian market and Rs. 100.79 crores worth of orders are for markets outside India.

Of the total outstanding consolidated order of Rs. 100.79 crores for markets out of India, Rs. 68.36 crores constitute orders for USA market and Rs. 32.43 crores constitute orders for rest of the world.

 As on 1st June 2018, further consolidated orders worth Rs. 24.23 crores are already negotiated and of this Rs. 20.23 crores worth of orders are from Indian market and Rs. 4.00 crores worth of orders are for markets outside India.
